## Requests For Security

The UK's comprehensive and robust regulatory framework is supported by a legal regime that can result in civil or criminal liability for businesses that are found to have conducted activities which threaten to undermine it. Advice and advocacy at all stages of investigations and disputes between tax authorities and taxpayer's as well as tax-related commercial, contractual and professional liability disputes, whether they are settled by negotiation, alternative dispute resolution or end up in court. In general, barristers engage in advocacy (trial work) and solicitors in office work, but there is a considerable overlap in their functions. The solicitor, for example, may appear as an advocate in the lower courts, whereas barristers are often called upon to give opinions or to draft documents. The Oxford Dictionary definition of tax states that tax is 'a compulsory contribution to state revenue'. Setting up and administering UK trusts can be advised upon by a tax barrister, as can succession planning and drafting wills. All professionals have a duty of confidentiality but only communications between clients and lawyers – solicitors and barristers – are subject to legal professional privilege. Because tax laws tend to be numerous and complicated, it would be impossible to subject them to complete review at all times. Capital gains tax is a matter that a tax barrister can give opinions on. ## Domestic And EU Courts

Tax barristers can provide advice on day to day tax issues arising from acquisition and sale of property portfolios. A few UK tax barristers represent clients in the Court of Justice of the European Union (CJEU) and occasionally in other jurisdictions such as Hong Kong, Mauritius and Singapore. A limited number of senior barristers receive 'silk' – becoming Queen's Counsel – as a mark of outstanding ability. They are normally instructed in very serious or complex cases. Most senior judges once practised as QCs. Lawyers and barristers can both represent clients inside the court. The only difference is, lawyers usually represent clients in the magistrate courts (or known as the lower courts). As for barristers, they usually represent clients in the higher courts. Failure to accurately report one's income is an offense punishable by penalties and possibly prosecution. Barristers can provide a range of services, including advising their clients on the strengths and weaknesses of their case. Tax avoidance explicitly hides the tax avoider from view, which is a key part of their attraction. It is, however, important to note that, despite current public perception to the contrary, the total loss of tax resulting from tax avoidance is substantially less than the losses that arise from tax evasion. Tax barristers find that being asked to advise or litigate an area that you have no experience of, or indeed which may never have been considered by the courts in detail before, is one of the most satisfying parts of the job.
